

# Notice of Public Hearing

Notice is hereby given that on 10 January 2023, the Philippine Electricity Market Corporation (PEMC) and the Independent Electricity Market Operator of the Philippines, Inc. (IEMOP) filed the Joint Application dated 26 October 2022 in the case titled, “In the Matter of the Application for the Issuance of Rules on the Price Determination Methodology for the Implementation of the Co-Optimized Energy and Reserve Market in the Wholesale Electricity Spot Market (WESM)” docketed as ERC Case No. 2023-002 RC.

The Joint Application was filed with the ERC seeking the latter’s approval of the amendments to the Price Determination Methodology for the Wholesale Electricity Spot Market (WESM) to include relevant methodologies and procedures for the trading of reserves or ancillary services in the WESM.
